

Brave the Shave Live sponsored by Greene King

Terms and Conditions

1. All participants must be aged 18 years or over at the time of entry and legally reside within the UK (including Channel Islands and Isle of Man).
2. Brave the Shave Live sponsored by Greene King (the "Event") will be managed and operated by and held at the venues of Greene King Brewing and Retailing Limited (the "Venue"). Any questions on the day should be directed to staff at the Venue.
3. Participants must arrive at least thirty minutes in advance of the advertised end-time of the Event in order to participate in the Event.
4. Your Event registration is individual to you and non-transferable.
5. If you wish to invite friends and family to the Event you must speak to the Venue. The Venue will make decisions on admission of non-registered attendees in its absolute discretion. The Venue may make such decisions for reasons including but not limited to venue capacity and health and safety.
6. Participants may be withdrawn from the Event or removed from the Event at the discretion of the Venue and at the discretion of Macmillan Cancer Support ("Macmillan") on the day of the Event, for reasons including but not limited to drunkenness, disorderly conduct, not cooperating with the Venue's instructions on the day, not complying with these Terms and Conditions, not complying with the Venue's terms and conditions, disruptive behaviour or any other behaviour deemed to be a risk to the reputation of Macmillan or the Venue, to health and safety, or to the smooth running of the Event, at the Venue and Macmillan's absolute discretion.
7. All funds raised through the Event must be payable to Macmillan Cancer Support in £ sterling and should be received by Macmillan Cancer Support within one month of the Event. The objective is to raise as much sponsorship as possible.
8. Should you, for whatever reason, not take part in the Event, all monies collected should be forwarded to Macmillan Cancer Support or returned to your sponsors.
9. Any complaints should be communicated to the Venue staff. Complaints may also be communicated to Macmillan, to a staff member if one is present at the Event, by telephone to the Macmillan supporter care telephone line, or in writing to the Macmillan Cancer Support office, as soon as possible after the Event.
10. By registering for the Event you agree that any information and data (personal data) provided by you will be held and may be used by Macmillan Cancer Support ("Macmillan") in order to conduct the Event, and it may be shared with Macmillan's agents, suppliers and contractors to the extent necessary for the Event to be carried out. Your name will be provided to the Venue in order to facilitate your participation in the Event. 11. Macmillan reserves the right to modify, cancel, terminate, postpone or suspend the Event in whole or in part, at its sole discretion, for any reason, until 27 August 2021. Macmillan will take reasonable steps to notify you of any such modification, cancellation, termination, postponement or suspension.
12. Macmillan reserves the right to modify, cancel, terminate, postpone or suspend the Event in whole or in part, at its sole discretion, until and including the day of the Event, if it believes the Event is not capable of being conducted as specified within these Terms and Conditions or if it believes there has arisen an incident such as a change in the law or government guidance, a health and safety risk, or any other cause that is beyond the reasonable control of Macmillan that could affect the administration, safety or normal course of the Event. Macmillan will take reasonable steps to notify you of any such modification, cancellation, termination, postponement or suspension.
13. Neither Macmillan nor Greene King nor any of their respective subsidiary or affiliated companies are responsible for any condition, circumstances, losses, failures or delays caused by anything beyond its or their control such as (but not limited to), the barbers at the Event or otherwise that may cause the Event to be disrupted.
14. You must comply with the terms and conditions, including health and safety requirements, of the Venue and any others who are involved in the administration of the Event including all health and safety guidelines and instructions and all applicable legal and regulatory requirements. You confirm you will comply with instructions provided by the Venue on the day of the Event.

15. By participating in the Event, you agree to release and hold Macmillan and Greene King, and their respective subsidiary and affiliated companies, together with their respective employees, officers, directors, agents and representatives, harmless from any and all losses, damages, rights, claims and actions of any kind in connection with participating in the Event provided that nothing in these Terms and Conditions shall in any way limit Macmillan's or Greene King's liability for death or personal injury caused by its negligence or for any other matter where liability may not as a matter of law be limited.
16. By registering for the Event, you agree to be bound by these terms and conditions ("Terms and Conditions"). Promotional materials relating to the Event also form part of these Terms and Conditions. If there is any conflict between any terms referred to in such promotional materials and these Terms and Conditions, these Terms and Conditions take precedence.
17. These Terms and Conditions are governed by English law. The courts of England and Wales shall have exclusive jurisdiction to hear any dispute or claim arising in association with the Event or these Terms and Conditions.
